Attached are preliminary financial summaries prepared by Heidi Spiegel from information submitted to her by VerJean and myself. Please note that this information summarizes the results of our club's activities from February 1 – October 13, 2008. Therefore, the November agility trial is not included. Hopefully, by January 3, we will have financial information that includes that trial. Please note that these

reports were generated from the Treasurer's Reports and our tax returns and may not have classified a few individual items correctly, but I believe that they are accurate enough for our purposes at this point in time.
